# The Difference between LCSH & FAST:

FAST (Faceted Application of Subject Terminology) is derived from LCSH (Library of Congress Subject Headings). It has its own subject vocabulary with a more simplified syntax for Web resources.

LCSH is broken down into separate headings: topical, geographic, and chronological and form.
